# **Draping the Charter**

I have been asked when and why we drape our Unit Charter. The answer is simple.

When a unit has lost one of its members due to death, it is customary to drape the unit charter with a black crepe during the period of mourning. There is no set time for how long the mourning period should be or how long the charter is draped.

I have provided here a suggested ceremony for draping the charter.

Unit President: We have assembled here at the call of our maker who has taken from us one of our beloved leaders. We have come to give, by a simple token, our official expression of the grief of Unit (unit name). Let us first bow our heads in prayer.

(Chaplain will offer a brief prayer.)

Unit President: We stand before the document which gave our unit life and being. Under its authority, years of devoted service were given by (name of deceased member). He/she contributed to its significance. His/her service is ended, but the results of his/her loyal efforts will go on and on for our American Legion Auxiliary and for God and country which the Auxiliary serves.

It is therefore fitting that on our charter, we should drape this black crepe, an expression of the sorrow in our hearts and of the mourning of (unit's name) over its great loss.

(Unit president then drapes the charter.)

Unit President: Now we ask God's blessing for our departed friend and co-worker, then go silently to carry forward the tasks to which he/she was giving so much when called away.

(Chaplain gives a brief concluding prayer.)

### MEMBER DATA FORM

The Department Chaplain shall receive a Member Data Form from the Unit Chaplain when notified of a member's death. This notification will provide me with the auxiliary member's name, so she will be remembered at the Department Convention Memorial Service.

A courtesy Member Data Form should also be sent to the District Chaplain with the deceased member's current year information, so again she will be remembered at the district meeting.

Over the years, I've met many people who didn't know Poppy Story. A copy can be found on our website. Please use and share with others.

In a past bulletin, I shared how Poppy Funds can be used per the new 2024 Poppy Guide. Our organization also uses Poppy Funds to support mission outreach activities, such as: National Veterans Creative Arts Festival, -Armed Services YMCA food pantry locations, and to Support Honor Flights. At DEC, we witnessed a beautiful presentation about the Honor Flights Program. Below is how Poppy Funds can be used to support the mission of Honor Flights. Hope your Unit can support a Veteran or Guardian on a future Honor Flight trip.

### Honor Flights

### For the veterans:

-Food and nutrition

-Oxygen

-Wheelchairs

-Medical teams on each flight (one medic per bus — and there are sometimes up to six medics per flight — funds cover the medic's food, identifying apparel, medical supplies, travel expenses, and hotel)

-Wheelchair-accessible buses

For the guardian (companion/caregiver who attends with the veteran)

-Airfare to accompany veteran on the trip

-Food and nutrition

-Hotel accommodations to remain with veteran during the trip

-Guardian training and associated needs to execute necessary tasks – food, room rental, medical training, and identifying articles of clothing

- -When required transportation to the airport with veteran
- -When required hotel for the night before the flight with veteran

□ Check the <u>2025 Reservation List</u> for accuracy. Send any corrections in an email to <u>alacagschair@gmail.com</u>.

 Download and start filling in the Full 2025 ALA GS Unit Information Packet.pdf or Individual Pages. YOU MUST DOWNLOAD THE FORM FIRST BEFORE YOU CAN USE THE AUTOMATIC FILL-IN SECTION. It does work when you download the document first.

□ When interviewing, ALWAYS explain to the Candidates that delegates cannot arrive late or leave early from the 2025 Girls State Session. They must attend the ENTIRE session. They cannot leave early for any reason **including illness** or they will not qualify for Citizenship, awards or pins. **AND** there is no time for other schoolwork, interviews or virtual meetings.

- □ Father's Day is on June 15th and we are in session on that day. Remind Delegates to tell their dads they will celebrate when they get home.
- □ Always select a Delegate and two Alternates. If there is not an Alternate, and if your Delegate does not attend, you will not receive a refund from Department.

□ When scoring candidates, initiate a <u>Tally</u> system. It can help to break ties, and you can verify that your selection was not discriminatory.

□ This is the site where you, Unit Chairs, should direct Delegates and Alternates to complete the online application. <u>cagirlsstate.org/delegates-alternates</u>. At the webpage the students then click START HERE for step-by-step instructions. Please to remind your applicants to **go line by line.... Do Not Skip Around**.

### National Security Bulletin 8 February 2025

Hello to all of my Strategic Planners. Did you know that the DoD POLICY ALLOWS VETERAN AND MILITARY SERVICE ORGANIZATIONS GREATER ACCESS Helping servicemembers transition from the military world to civilian life is among the top priorities of The American Legion Family.

The Department of Defense (DoD) has made access to troops and their families easier than ever. At the urging of The American Legion and other organizations, DoD approved two policy memoranda that direct military services to allow veteran and military service organizations (VSOs/MSOs) greater and more standardized access to installations, their troops, and families. The American Legion worked with DoD staff to shape the policy to increase the presence of service officers at installations and to create greater troop and military family awareness of American Legion support programs, such as Operation Comfort Warriors (OCW), transition assistance, career support and more.

American Legion Family departments, districts and posts/units are encouraged to use this publication as a resource for working with military installations to help troops ease the transition from military to civilian life.

Now is the time to submit the American Legion Auxiliary's Salute to Servicemembers Award. This year it is much easier to submit for this award. An ALA member/entity simply makes the nomination, rather than the servicemember, to effectively tell the story of why they feel this person is head and shoulders above their peers and worthy of this award.

A simple narrative of no more than 1000 words, a picture of the servicemember (preferably official Department of Defense photo) and the endorsement from their command group are the only requirements. The deadline is June 1, 2025, but it is better to submit now. The nomination form is live now. Simply click <u>https://ww.legion-aux.org/Salute-to-Servicewomen-Award</u> with the nomination form at <u>https://member.legion-aux.org/Salute-to-Servicemembers</u>.

As we all know, the fires in Southern California have claimed lives and many people have lost their homes and businesses. As of DEC reporting, there were over 100 Legion Family members who lost their homes or businesses. Please continue to donate money and items. Get with your Posts and have a joint fundraiser to raise funds for our Legion Family members.
