National Headquarters ensures all is accurate and meets the requirements for a new charter. The new charter is issued to Departments with the sitting National President and sitting National Secretary signatures. This is how National Headquarters knows what year each unit is chartered. National Headquarters then sends the new charter to Department for completion.

The Department receives the new charters and obtains signatures of the sitting Department President and sitting Department Secretary.

During DEC (Department Executive Committee) or Department Convention new charters are presented and recognized by the Department body.

National Headquarters do not have copies of Charters with National and Department signatures.

National President Trish Ward has stated she is a "History Buff," and has respectfully requested a "snapshot," or photocopy of charters as a fun History project.

It would be greatly appreciated for units to send "snapshots," or photocopies of their charters to their District Historian.

Estimates show California faces a shortage of about 36,000 licensed nurses, according to the UC San Francisco Health Workforce Research Center on Long-Term Care. (Jul 31, 2023)

Forecasts of the Registered Nurse Workforce in California (As Reported in UC San Francisco by Joanne Spetz, Lela Chu, and Lisel Blash (August 2022)

This study used data from two surveys conducted in California and other data sources to assess the current and future supply and demand of RNs. We find that RN employment rates have remained steady over the past four years, but many older RNs have left nursing.

In addition, a large proportion of older RN intends to retire or quit within the next two years. Many RNs report that childcare and school closures have made it difficult to work during the pandemic and reported they feel unsupported by their employers. The supply and demand projections estimate that a shortage of RNs now exists but will diminish as RN education enrollments return to and surpass pre pandemic levels.

All Abou the Fisher House Foundation, Inc.

Since its inception in the early 1990's the Fisher House Foundation has provided lodging to some 500,000 military families and families of veterans receiving medical care at VA facilities. These homes away from home offer free accommodations to the families, allowing them to be close to their loved one during a medical crisis and focus on the healing process. Today, there are 101 Fisher Houses' located in the U.S., Germany, and the United Kingdom. California is currently home to six Fisher Houses':

- Travis Air Force Base Fisher House, David Grant USAFMC, Travis AFB, Travis, CA
- Los Angeles Fisher House, Greater Los Angeles VAHCS, Los Angeles, CA
- Long Beach Fisher House, Long Beach VAHCS, Long Beach, CA
- Camp Pendleton Fisher House, Naval Hospital Camp Pendleton, Oceanside, CA
- Palo Alto Fisher House, Palo Alto VAHCS, Palo Alto, CA
- San Diego Fisher House, San Diego VAHCS, San Diego, CA

In the last 35 years more than 12 million lodging nights have been offered to these families at a savings of approximately \$610 million in transportation and lodging fees.

The Fisher House Foundation also operates the Hero Miles program, using donated frequent flyer miles to bring family members to the bedside of injured service members, as well as the Hotels for Heroes program using donated hotel points to allow family members to stay at hotels near medical centers without charge. The Foundation also manages a grant program that supports other charities and scholarship funds for military children, spouses, and children of fallen and disabled veterans.

- If a Delegate can no longer attend, and the unit does not have any selected Alternates, contact me after April 2nd to request details about the "2025 Department Alternate Applications" for students who were unable to find an ALA Unit to sponsor their school.

An ALA member/entity simply makes the nomination, rather then the servicemember, to effectively tell the story of why they feel this person is "head and shoulders" above their peers and worth of this award. For example, all recipients of last year's Salute to Servicemembers Award are tremendous assets to their military community, thriving in their professional careers with awards and decorations to prove it, but all demonstrate the spirit of volunteerism.

At the very least, the goal is to have at least one submission from every Department and ensure that every branch of the military is represented – Army, Navy, Marine Corps, Air Force, Coast Guard. Space Force and the National Guard/Reserve. With our military installations, big and small, throughout the country, we have a huge number of service members to choose from. Let's remember our Mission to support our military and enter those service members that are so deserving.

A simple narrative of no more than 1000 words, a picture of the servicemember (preferably official Department of Defense photo) and the endorsement from their command group are the only requirements.
