Moved, by Finance Chairman, Geri Fitzpatrick, seconded and carried to approve a \$.50 an hour raise for the Department Membership and \$1.00 raise for the Department Bookkeeper.

It was moved, seconded and carried to approve the Electronic Communications, Internet, and social Media Policy Guidelines.

Pilar Reyes reported the American Legion, Department of California, voted at their March DEC meeting to relocate its headquarters from San Francisco to Sanger, CA. In April approximately 5 Auxiliary members along with Department President Harriet visited Sanger and had a tour and thorough scrutiny of the vacant building that used to be West America Bank. The building is huge and covers almost a city block with ample parking space and can house the whole Legion family and other ancillary groups tied with the American Legion. At this convention the Legion will vote on a resolution to reject and declare null and void the action of the Legion at their March DEC meeting to approve a contract for purchase of the vacant building at Sanger. Whatever decision the Legion makes will affect the Auxiliary. There are two options for the Legion to choose to make their decision: The Legion will move to Sanger or they will stay in San Francisco. The Legion's decision will affect the Auxiliary: If the Legion decides to move to Sanger then we will vote on where we want to go. If the Legion decides to stay in San Francisco, there is nothing to vote on.
