## ELECTION/TRANSMITTAL OF DELEGATES AND ALTERNATES CONVENTION 2024 INSTRUCTION

Article IX, Section 9, Department Bylaws -Units shall elect delegates and alternates to the Department Convention at least fifteen (15) days prior to the date set for the District pre-convention caucus, but not earlier than April $1^{\text {st }}$.

Article VI, Section 2, Department Constitution- ... Each Unit shall be entitled to two (2) delegates and two (2) alternates for charter and one (1) additional delegate and one (1) alternate for each seventy-five (75) members or major fraction thereof, paid up in Department Headquarters forty-five (45) days prior to opening of Department Convention.

This fee must be paid regardless of whether any delegates from the Unit are/are not attending convention:

The same number of Alternates are elected as are delegates.
